Defendant, RiverHills Bank (“RiverHills”), by and through counsel, submits its response to The UPS Store, Inc.’s (“TUPSS) Motions (1) to Consolidate Related Actions, and (2) to Stay or to Modify Case Schedule [Doc. #102] [Doc. #105] [Doc. #108], and in support thereof, states as follows:

1. RiverHills has no objection to the consolidation of the related actions and/or “investor loss cases” for discovery purposes. TUPSS’s pending motion to consolidate does not request that the related actions and/or “investor loss cases” be consolidated for purposes of trial, so RiverHills takes no position with respect to that issue because it is not before the court for its consideration.

2. With respect to TUPSS's request that this action be stayed and/or that the existing case management order be amended, RiverHills takes no formal position regarding whether this action should be stayed, but, in the event consolidation for discovery purposes occurs, the existing deadlines should be amended and extended.
